## KEY TRANSFER REQUEST FORM

Keys are issued to property owners only, with a maximum of four (4) keys per 1  $\frac{1}{4}$  acre (+/-) lot: one key per owner per deed per parcel number. If a lot has been split into .31-acre (+/-) parcels, then only one key per .31-acre parcel number can be issued, no matter how many owners.

**IF YOU HAVE SOLD THE ONLY SUBURBAN PARCEL THAT YOU OWN, THE KEY(S) ASSIGNED TO THAT PARCEL MUST BE TRANSFERRED TO THE NEW PROPERTY OWNER(S).** If you have more keys in your possession than new owners, then you must relinquish the remaining key(s) to SEPA Club Inc.; failure to do so will result in the key being reported as Stolen and it will be confiscated when found per SEPA Club Inc By-Laws.

If you own another parcel that doesn't have a key assigned to it, you may transfer your key to the second parcel, as long as the names and number of owners remain the same, and no other keys have been issued on that parcel. This will be verified.
